The Minister of Financial Affairs of Gandaki Province, Hon. Dr. Takraj Gurung, presented the Budget for the province for the fiscal year 2024/25 on June 15, 2024.

Budget Objectives:

- Enhancement in quality infrastructure and production
- Increase employment and income
- Building human capital, establishing an equitable distribution of the benefits of development.
- Achieving social justice and development
- Enhancing good governance through quality public service delivery

Budget Priorities:

- Building resilient and sustainable infrastructure
- Increase in income generation and employment
- Social development and establishment of an equitable society
- Accessible health and quality education
- Balanced sectoral development
- Promotion of good governance, quality service delivery and cross-level linkages

Budget Highlights

- The **Gross Domestic Product** (GDP) of Gandaki Province at the basic price for FY 2023/24 is estimated to be NRs. 51 billion 670 million, amounting to current growth of 4.55% over FY 2022/23.
- **Per capita Income** is estimated to be \$1557 in 2023/24.
- Expenditure (excluding share investments in other institutions) in FY 2024-25 is estimated to be NRs. 32 billion 678 million and 575 thousand.
- Revenue Receipts (excluding loans) in FY 2024-25 are estimated to be NRs. 31 billion 278 million and 575 thousand. In FY 2023-24, the revised revenue receipts (excluding loans) are NRs.28 billion, 937 million, and 103 thousand.
- **Fiscal Deficit :** In order to fulfill this deficit, the province will be taking loans of NRs. 1 billion 700 million from other internal governments, NRs. 300 millions of remaining funds from loans will be invested in share investments in other institutions.

Policy Highlights

• Self-sufficient and prosperous province: Respected province residents: In order to complete the development roadmap set by the second five-year plan, emphasis has been put forward to increase production and productivity, create jobs, enhance the interests of the citizens of the province, and contribute to the overall development of the province. Giving importance to the role of the private sector in

the regional economy, an allocation of a certain amount of budget has been formulated emphasizing investment promotion through the participation of the public and private sectors.

- Greater animal Development Promotion Program and Fishery Development Project: An allocation of 35.1 million budget has been allocated for export promotion by increasing the production of milk, eggs and fish in the province.
- A budget of 126 million 275 thousand has been arranged for the program to make Gandaki province self-sufficient in food, vegetables, fruits, fish, meat and potato production. In addition, the rural nutrition security program has been continued to improve the nutritional status of food and nutrition insecure communities.
- Healthy Life, Our Joyous Aim: Through the Healthy Life Campaign, allocation of 10 million budget has been emphasized on conducting the **Gandaki Awakening Campaign** with civic education, parent education as well as meditation and yoga camps along with social awareness campaign and awareness for the end of exploitation and discrimination including caste discrimination and untouchability.
- **Journalism**: Special arrangements have been made for the development and expansion of mass media and journalism in Gandaki province. As an incentive to the journalists within the province, the necessary budget has been allocated for conducting the journalist capacity development program and journalist writing fellowship program.
- **Disaster Risk Reduction:** An allocation of 100 million budget has been arranged as a minimum balance in the Provincial Disaster Management Fund for Disaster Response. A special program will be conducted to rebuild the disaster preparedness response after completing the identification and mapping of risk areas within Gandaki province.
- Conscious consumers, responsible producers and sellers: Allocation of
 certain amounts of budget has been managed in order to protect and promote
 consumer interests, market monitoring and to conduct public-private dialogue
 programs.
- Youth and Sports: The infrastructure construction work of a high altitude sports
 training center has been started in the next financial year and the necessary
 arrangements have been made for conducting a high altitude sports program for
 high altitude sports.

Budget allocation to the ministries:

- Ministry of Chief Minister Office: 1 billion 5 million 498 thousand, sharing 3.05%.
- Ministry of Financial Affairs: 171 million 499 thousands, sharing 0.52%.
- Ministry of Agriculture and Land Management : 2 billion 92 million 107 thousands, sharing 6.34%.
- Ministry of Social Development and Health: 5 billion 477 million 416 thousands, sharing 16.61%.
- Ministry of Energy, Water resources and Drinking water: 4 billion 25 million 389 thousand, sharing 12.21%
- Ministry of Physical Infrastructure Development and Transport: 12 billion 701 million 6 thousand Sixty Six, sharing 38.51%.

• Ministry of Industry, Tourism, Forest and Environment: 1 billion 584 million 430 thousands, sharing 4.80%.

Budget Estimates for FY 2024/25

- The total expenditure in FY 2024-25 is estimated to be NRs. 32 billion 978 million and 575 thousand. This expenditure is proposed to be met through NRs. 13 billion 84 million 700 thousands from Federal Grants, NRs. 9 billion 611 million and 200 thousand from Revenue Sharing, NRs. 481 million from Royalty Sharing and NRs. 5 billion, 170 million from Internal Revenue.
- The revised expenditure estimates of FY 2023-24 is NRs. 23 billion 2 million and 687 thousand. It has decreased from an estimated expenditure of 33 billion 427 million 200 thousand by 31.18%.

Expenditure in FY 2024-25


Current Expenditure f for FY 2024-25 is estimated to be NRs. 13 billion 160 million and 582 thousand, a total of 39.91% from total allocation, an increase of 23.79% over the estimate of FY 2023-24.

Capital Expenditure for FY 2024-25 is estimated to be NRs. 19 billion 517 million and 993 thousand, a total of 59.19% from total allocation, a decrease of 3.31% over the estimate of FY 2023-24.

Receipts in FY 2024-25:

- Total Revenue Receipts for FY 2024-25 is estimated to be NRs. 30 billion 792 million and 975 thousands of which NRs.13 billion 84 million 700 thousands received from the federal grants, NRs. 9 billion 611 million and 200 thousands from Revenue sharing, NRs. 481 million from royalty sharing, NRs. 5 billion 170 million from internal revenue.
- **Grants from Federal Government** in 2024-25 is estimated to be NRs. 13 billion and 84 million 700 thousands which is 39.68% of total budget of the province. In FY 2023-24, grants from the federal government contributed to 57.8% of the total budget.
- Internal Revenue for FY 2024-25 is estimated to be NRs. 5 billion 170 million, which has increased by 0.015% from the estimates of FY 2023-24. Internal Revenue as a percentage of expenditure contributes to approximately 15.67

Sources of Province's own-tax revenue

The estimates for Gandaki Province's own source revenue in FY 2024/25 show significant variations across different tax categories. While the Agricultural Income Tax is projected to decrease by 31%, the House & Land Registration Fee is expected to see a dramatic increase of 98.91%, indicating a strategic shift or anticipated economic activity in property transactions. The Entertainment & Advertisement Tax is also forecasted to rise by 16.96%, reflecting a positive outlook for the entertainment and advertising sectors.

Gender-responsive budgeting (GRB), is an approach to budgeting that takes into account the various needs of a diverse population by using an intersectional gender lens to respond to the different experiences of women, men, and gender-diverse groups. According to the Budget speech of 2024/25, 33.30 % of total budget lies under direct benefit of Gender Responsive Budgeting ,58.89% lies on indirect benefit and 7.81% lies on neutral.



Cost Estimation for Climate Responsive Budgeting:

Climate responsive budgeting (CRB) is an approach to budgeting that integrates climate change considerations into all stages of the budgetary process, from planning and formulation to implementation, monitoring, and evaluation in order to ensure that allocated public funds are spent in ways that address the impacts of climate change, promote climate resilience, and support sustainable development.

According to the Budget speech of 2024/25, 10.25 % of total budget lies under direct benefit of Climate responsive budgeting, 62.10% lies on indirect benefit and 27.65% lies on neutral.









Comparison of Provinces' Expenditure on Key Functions.


Figure 2 : Comparison of Province's Expenditure on Key Functions



Residential and Community Facilities






